In order to qualify for this scholarship a student must meet the following criteria:

1. The applicant must graduate from Horton High School.
2. Financial need must be shown.
3. The applicant must attend an educational institution to further his/her education beyond high school.
4. The applicant must seek post-secondary education in agriculture or related field.

The recipient will be chosen by a committee representing the John and Thelma Tate Memorial Scholarship Funds.
